V. ADMINISTRATIVE COMMUNICATIONS

A. Chief's Report

Chief Thompson commented that he has held one general staff meeting and two command meetings since February. Both meetings have gone extremely well and his written expectations have been distributed to all staff members. Chief Thompson has meetings set up with the Captains on March 29th and with the part-time staff on April 5th, where he will discuss any issues they have an also review expectations. Chief Thompson also met with the Cotati Mayor and City Manager and they had a nice conversation.

Next week company inspections will be done on all shifts to see equipment, apparatus, stations and records. Chief Thompson will then graph and provide information on some of the things he comes across. He has also met with Bill Adams, District Counsel and in another meeting, our Union President, where they talked about putting together an IAFF fitness program in the coming year.

Mrs. Grube reported that we have 29% remaining and in supplies and services we have a -14% since we purchased the SCBAs through the grant. She deferred this to Ms. Ober for further explanation. Ms. Ober commented that the new SCBAs were purchased out of account 6165, but the grant money must be shown as revenues, which hit account 2500. This leaves the budget looking as though there is a deficit, however, we do still have fund available.

F. Firefighter's Union Report

The Union also obtained a retainer with a law firm to help them with negotiations and any personnel issues.
